general info

1. To be considered, all entries must be submitted on DVD (NTSC format only) labeled with Your name, Title of Film, Category and Running Time and completed Entry Form.
2. All entrees must be submitted by December 15, 2009.
3. A fifty word or less synopsis for marketing should accompany your film, along with a still.
4. Features are 50 minutes or greater, shorts must be 50 minutes or less.
5. Films with US or foreign distribution or films produced by a major studio, or under contract or option, are ineligible for competition. Documentaries screened on US or foreign television are also ineligible for competition purposes.
6. Films will not be returned and we are not responsible for lost or stolen materials.
7. Filmmakers will be notified if their work is chosen prior to January 15, 2010.
8. Once material has been accepted this agreement constitutes irrevocable approval by you to the Kent Film Festival to screen at the 2010 festival.

submissions

fee schedule:

EARLY DEADLINE must be postmarked by July 15, 2009

\$35 for shorts, \$55 for narrative features/documentaries \$25 Student

REGULAR DEADLINE must be postmarked by October 15, 2009

\$45 for shorts, \$65 for narrative features/documentaries \$30 Student

LATE DEADLINE must be postmarked by December 15, 2009

\$55 for shorts, \$75 for narrative features/documentaries \$35 Student

all students MUST send a copy of their student ID

entry fees:

Personal check (payable to the Kent Film Festival) or online payment

if paying from outside the US, payment must be made by a credit card only.

If paying online a copy of the paid receipt must accompany the completed submission form.

Any returned checks will result in immediate disqualification.
